Whereas policy for Quality Control for Roads in Punjab PWD B&R was issued vide notification no. 10/126/2016-BR1(3)/896574/1 dated 22.12.2016 and Policy for Quality Control for Buildings in Punjab PWD B&R was issued vide notification no. 10/126/2016-BR1(3)/896565/1 dated 22.12.2016, in which some works such as World Bank Projects and where NPMS, NQMs and third party audit is already in place were excluded from the preview of Quality Control Cell of Punjab PWD B&R.

After reconsideration the Govt. has decided that though the above said works have been excluded from the preview of Quality Control Cell of Punjab PWD B&R but random checking of these works on instructions from PWD Minister/ Secretary will be done by the Quality Control Cell of the Department. The above mentioned policies may be deemed to be amended to this extent.

Policy for Quality Control for Buildings in Punjab PWD (B&R)

The planning and design of each building structure should be users friendly and structurally safe in all respects especially in case of earthquakes etc. The highest standards of quality in all types of materials to be used in case of building should be ensured by testing each material at source as well as in the site laboratory. During the construction of any building, a strict supervision & regular visits of inspecting officers is very essential to achieve desired standards of quality so that the structure sustains its design, life & functionality with little annual maintenance:-

1. It would be mandatory for the Quality Control Cell, Mohali to check all the building works being executed by the PWD (B&R), where value of the contract is more than Rs. 2 Crore. All other works costing less than Rs. 2 Crore shall be checked by the concerned Superintending Engineers at their own level with **Mobile Based App** and uploaded on **WOMS website**. However, in case of any complaint of any work irrespective of any amount, the same shall be investigated by the Chief Engineer, (Quality Control).

2. Checking by Quality Control Cell or by the concerned SE shall be conducted at the following stages:-

STAGE-1: At Plinth level

STAGE-2: After 50% completion of work.

STAGE-3: During execution of finishing items and before handing over building to the Client Department.

(Note: It shall be mandatory on the part of the concerned Executive Engineers to get all the building works as per Sr. No. 1 under their jurisdiction checked from the Quality Control Cell at all three stages.)

3. No building work shall be checked by the Quality Control Cell after it is taken over by the Client Department except where there is a complaint for premature failure of the building.

4. The financial loss during Stage-1 & Stage-2 Checkings shall be calculated only for those items which cannot be rectified by the agency. Otherwise the Quality Control Cell shall point out the deficiencies which shall be rectified by the agency at its own cost and report in this regard shall be sent to the Quality Control Cell by the concerned Executive

Engineer through Superintending Engineer within 21 days from the date of inspection.

5. The Quality Control Cell and SEs shall be equipped with the latest equipments for Universal Testing Machine in the Quality Control Laboratory at Patiala and CAPO test for testing concrete at site for conducting the quality control tests for which the funds shall be provided by the Punjab Roads & Bridges Development Board.
6. The inspections by Chief Engineers, Superintending Engineers and Executive Engineers shall be carried out with Mobile Based App and uploaded on WOMS website.
7. Before passing and releasing any payment of the running/final bill of the contractor, the Executive Engineers will satisfy themselves regarding quality of work executed at site.
