Whereas policy for Quality Control for Roads in Punjab PWD B&R was issued vide notification no. 10/126/2016-BR1(3)/896574/1 dated 22.12.2016 and Policy for Quality Control for Buildings in Punjab PWD B&R was issued vide notification no. 10/126/2016-BR1(3)/896565/1 dated 22.12.2016, in which some works such as World Bank Projects and where NPMS, NQMs and third party audit is already in place were excluded from the preview of Quality Control Cell of Punjab PWD B&R.

After reconsideration the Govt. has decided that though the above said works have been excluded from the preview of Quality Control Cell of Punjab PWD B&R but random checking of these works on instructions from PWD Minister/ Secretary will be done by the Quality Control Cell of the Department. The above mentioned policies may be deemed to be amended to this extent.

Policy for Quality Control for Roads in Punjab PWD (B&R)

For constant growth of trade, commerce & the state's economy in general, maintenance of a healthy road network is imperative. The road network can be kept in proper shape by adopting a comprehensive quality control policy both for construction of new roads and subsequent repair and maintenance. In order to achieve these objectives, Public Works Department (B&R) would adopt the following for Quality Control of Roads :-

1. It would be mandatory for the Quality Control Cell, Mohali to check all the road works(except World Bank (OPRC) Projects and where NPMs, NQMs and third party audit is already in place)being executed by the PWD (B&R), where value of the contract is more than Rs. 2 crores. For determining the cut off point of Rs. 2 crores, market committee shall be treated as unit. All other road works costing less than Rs. 2 crores shall be checked by the concerned Superintending Engineers at their own level with **Mobile Based App** and uploaded on **WOMS website**. However, in case of any complaint of any work including those excluded above and irrespective of any amount, the same shall be investigated by the Chief Engineer, (Quality Control).
2. Checking by Quality Control Cell shall be conducted in two stages :-

STAGE-1 : During execution of work.

- (i) On completion of sub base.
- (ii) On completion of base.
- (iii) During the laying bituminous layer.

STAGE-2 : Within three months from the date of completion of the work.

(Note : It shall be mandatory on the part of the concerned Executive Engineers to get all the road works, as mentioned under Sr. No. 1 above under their jurisdiction checked from the Quality Control Cell at both Stage-1 & Stage-2 and a completion report would invariably be sent by the concerned XEN to Quality Control Cell within 7 days after completion of a particular work).

3. No work shall be checked by the Quality Control Cell three months after the date of completion of the work except where there is a complaint for premature damage/failure etc. of the road.

4. The financial loss during Stage-1 checking shall be calculated only for those items which cannot be rectified by the agency. Otherwise the Quality Control Cell shall point out the deficiencies which shall be rectified by the agency at its own cost and report in this regard shall be sent to the Quality Control Cell by the concerned Executive Engineer through Superintending Engineer within 21 days from the date of inspection.
5. The Quality Control Cell shall be equipped with the latest equipments for bitumen extraction test, nuclear density test and CAPO test for concrete at site for conducting the quality control tests for which the funds shall be provided by the Punjab Roads and Bridges Development Board.
6. The inspections by Chief Engineers, Superintending Engineers and Executive Engineers shall be carried out with **Mobile Based App** and uploaded on **WOMS website**.
